Parking potential

The Town of Vienna is considering purchasing a floor of a proposed four-story building on Mill Street that would provide about 127 public parking spaces. As part of its decision-making process, Town Council will hold a public hearing on this matter at its Feb. 26 meeting, which begins at 8 pm. The general public may voice feedback (either concerns and opposition or support or questions) at the public hearing.

Council is expected to vote on the parking garage proposal at its March 12 meeting. Providing additional parking opportunities to promote park-once, walk-more accessibility to Vienna's commercial area has been a long-term Town goal.

Nominate a 'rock star' business

Do you know a Town of Vienna business or business owner who is a rock star when it comes to supporting the community? If so, please nominate them for the 2018 Carole Wolfand Award.

Nominations should include:

- name, address, and phone number of nominated business
- a description, in 200 words or less, of the business's contributions/actions and why you believe it deserves to be recognized
- nominator's name, address, and phone number.

About temporary banners

Town businesses are allowed to post one temporary sign/banner for a 30-day period within a single calendar year. Temporary sign permits are issued for very limited purposes, such as special anniversaries or events, and cannot be used to advertise or promote sales. (The only exception is for temporary signage for the lease or sale of commercial property, which may be used for up to six months.)

Temporary sign permit information and an application are available [online](#). The fee is \$95, and administrative review requires 3-5 business days. The Town recommends that businesses not make a banner before receiving approval.

Temporary signs are limited to two square feet of sign area per one linear foot of building or store frontage. Temporary signs may be placed on the building or the business's private property, not on public rights-of-way. Zoning inspectors may pull illegally placed signs, but try to work with business owners to come into compliance. No moving signs or banners are allowed.
