**Vendors are responsible for paying all state and \*local sales tax in order to participate in Town events.** All vendors must pass an inspection by the Fairfax County Fire Marshal at the event.\* Note as of January 1, 2025 Town of Vienna Food Vendors Meal tax will be included in your total vendor fee.
